What is this medicine?

DIAZEPAM (dye AZ e pam) is a benzodiazepine. It is used to treat anxiety and nervousness. It also can help treat alcohol withdrawal, relax muscles, and treat certain types of seizures.

This medicine may be used for other purposes; ask your health care provider or pharmacist if you have questions.

How should I use this medicine?

Take this medicine by mouth with a glass of water. Follow the directions on the prescription label. If this medicine upsets your stomach, take it with food or milk. Take your doses at regular intervals. Do not take your medicine more often than directed. If you have been taking this medicine regularly for some time, do not suddenly stop taking it. You must gradually reduce the dose or you may get severe side effects. Ask your doctor or health care professional for advice. Even after you stop taking this medicine it can still affect your body for several days.\n\nA special MedGuide will be given to you by the pharmacist with each prescription and refill. Be sure to read this information carefully each time.\n\nTalk to your pediatrician regarding the use of this medicine in children. Special care may be needed.

Overdosage: If you think you have taken too much of this medicine contact a poison control center or emergency room at once.\nNOTE: This medicine is only for you. Do not share this medicine with others.

What should I tell my health care provider before I take this medicine?

They need to know if you have any of these conditions\n-an alcohol or drug abuse problem\n-bipolar disorder, depression, psychosis or other mental health condition'n-glaucoma'n-kidney or liver disease'n-lung or breathing disease'n-myasthenia gravis'n-Parkinson's disease'n-seizures or a history of seizures'n-suicidal thoughts'n-an unusual or allergic reaction to diazepam, other benzodiazepines, foods, dyes, or preservatives'n-pregnant or trying to get pregnant'n-breast-feeding

What if I miss a dose?

If you miss a dose, take it as soon as you can. If it is almost time for your next dose, take only that dose. Do not take double

Where should I keep my medicine?

Keep out of the reach of children. This medicine can be abused. Keep your medicine in a safe place to protect it from theft. Do not share this medicine with anyone. Selling or giving away this medicine is dangerous and against the law.\(\text{in}\) in This medicine may cause accidental overdose and death if taken by other adults, children, or pets. Mix any unused medicine with a substance like cat litter or coffee grounds. Then throw the medicine away in a sealed container like a sealed bag or a coffee can with a lid. Do not use the medicine after the expiration date. \(\text{in}\) \inStore at room temperature between 15 and 30 degrees C (59 and 86 degrees F). Protect from light. Keep container tightly closed.

What should I watch for while using this medicine?

What side effects may I notice from receiving this medicine?

Side effects that you should report to your doctor or health care professional as soon as possible:\n\n -allergic reactions like skin rash, itching or hives, swelling of the face, lips, or tongue\n -breathing problems\n -confusion\n -loss of balance or coordination\n -signs and symptoms of low blood pressure like dizziness; feeling faint or lightheaded, falls; unusually weak or tired\n -suicidal thoughts or other mood changes\n -trouble passing urine or change in the amount of urine\n \nSide effects that usually do not require medical attention (report to your doctor or health care professional if they continue or are bothersome):\n\n -dizziness\n -headache\n -nausea, vomiting\n -tiredness
